

WHEREAS, Radcliffe Bobbitt Adams Polley PLLC, the Attorney and designated agent for Far Hills Utility District (the "District"), is the authority responsible for having the official ballot prepared for the District's November 8, 2022 Directors Election (the "Election"); and

WHEREAS, the filing deadline for placement on the ballot for the Election was 5:00 p.m. on August 22, 2022, and the filing deadline for placement on the list of approved write-in candidates for the Election was 5:00 p.m. on August 26, 2022; and

WHEREAS, pursuant to the provisions of Section 2.052, Texas Election Code, as amended, Radcliffe Bobbitt Adams Polley PLLC has certified in writing to the Board of Directors (the "Board") of the District that the candidates to be listed on the ballot for the election are unopposed, only one candidate's name will appear on the ballot for each open position and no candidate's name will be placed on an approved list of write-in candidates for the office of Director of the District; and

WHEREAS, pursuant to the provisions of Section 2.053, Texas Election Code, as amended, the Board of the District is required to declare unopposed candidates elected to office.

<u>Section 1</u>: The Board of the District hereby declares the following unopposed candidates to be elected to the office of Director of the District:

Each candidate declared elected to office shall serve until the biennial directors election in the year 2026, or until his/her successor has been duly elected or appointed and has qualified.
