## ORDER SETTING RATE AND LEVYING TAX FOR 2022

WHEREAS, Far Hills Utility District (the "District") has issued and sold certain bonds; and

WHEREAS, Texas Water Code, §51.339, as amended, provides that the Board of Directors of the District (the "Board") is required to levy and cause to be assessed and collected ad valorem taxes upon all property (real, personal or mixed) subject to taxation within the boundaries of the District sufficient to pay the interest on any bonds issued by the District, and create a sinking fund which includes a debt service fund sufficient to redeem and discharge the bonds at maturity or at any earlier required redemption date, the District must levy a tax on all taxable property in the District to provide for payment of interest on and principal of its bonds as said bonds mature; and

WHEREAS, Texas Water Code, §49.107, as amended, provides that the District may levy and collect a tax for operation and maintenance purposes, including funds for planning, constructing, acquiring, maintaining, repairing, and operating all necessary land, plants, facilities, improvements, appliances, and equipment of the District and for paying costs of proper services, engineering and legal fees, and organization and administrative expenses; and

WHEREAS, Texas Water Code, §49.236, as amended, provides that before the Board adopts an ad valorem tax rate for debt service, operation and maintenance purposes, or contract purposes, the Board shall give notice of each meeting of the Board at which the adoption of a tax rate will be considered, such notice of the public hearing on the District's tax rate shall be in substantially the form set forth in Texas Water Code, §49.236, as amended, and shall be published at least once in a newspaper having general circulation in the District at least seven (7) days before the date of the hearing or mailed to each owner of taxable property in the District at the address for notice shown on the most recently certified tax roll of the District, at least ten (10) days before the date of the hearing; and

WHEREAS, Texas Water Code, §49.236, as amended, provides that, for developing districts, if the Board adopts a combined debt service, operation and maintenance, and contract tax rate that would impose more than 1.08 times the amount of tax imposed by the District in the preceding year on a residence homestead appraised at the average appraised value of a residence homestead in the District in that year, disregarding any homestead exemption available only to disabled persons or persons 65 years of age or older, an election shall be held to determine whether or not to reduce the tax rate adopted for the current year to the voter approval tax rate in accordance with the procedures provided by Texas Tax Code, §26.07(b)-(g); and

WHEREAS, the Tax Assessor and Collector for the District has received the certified tax roll from the Montgomery Central Appraisal District assessing the 2022 valuation of District property and presented such information to the Board for its consideration in setting the 2022 tax rate; and

WHEREAS, the Board has received the calculation from the Montgomery County Tax Assessor/Collector and the Financial Advisor of the District indicating the tax rate for the current year necessary to pay principal of and interest on bonds and certain other obligations of the District; and

WHEREAS, the Board has previously found that the District is a developing district under Texas Water Code, §49.236; and

WHEREAS, the Board finds that the portion of the tax levy for debt service purposes in this Order are sufficient to provide for the District's debt service as required by Texas Water Code, §51.433, as amended, and the portion of the tax levy for operations and maintenance purposes of the District are permitted by Texas Water Code, §49.107, as amended.

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF DIRECTORS OF FAR HILLS UTILITY DISTRICT, THAT:

- Section 1. The Board hereby finds that prior to adopting the ad valorem tax rate for 2022, the District has provided proper notice of the public hearing to set the District's tax rate and otherwise satisfied the requirements of Texas Water Code, §49.236, as amended.
- Section 2. The Board hereby levies and causes to be assessed upon all property (real, personal or mixed) subject to taxation within the District a total ad valorem tax rate of \$0.64 per \$100 of assessed value for the 2022 tax year, comprised of \$0.355 per \$100 assessed valuation for debt service purposes and \$0.285 per \$100 assessed valuation for operation and maintenance purposes. The District's Tax Assessor and Collector shall take all steps necessary and authorized by law to collect taxes as owed pursuant to this Order. Said ad valorem taxes shall be levied, assessed and collected at the rate of \$0.64 per \$100 of assessed valuation as provided for in Chapter 49, Texas Water Code, and all other applicable laws.
- Section 3. The Board hereby finds that the total ad valorem tax rate of \$0.64 per \$100 of assessed value for the 2022 tax year does not impose more than 1.08 times the amount of tax imposed by the District in the preceding year.
- Section 4. Pursuant to law, all taxes shall be due and payable on or before the 31<sup>st</sup> day of January, 2023.
- <u>Section 5</u>. The President or Vice President is authorized to do all things necessary for execution of this Order, and the President or Vice President is further authorized to execute, and the Secretary or any Assistant Secretary to attest, this Order on behalf of the Board of Directors.
